TO:All Garmin Aviation Service CentersDATE:November 11, 2015SUBJECT:GTN 650 and GTN 750 Notification of Mod Level 5 per Service Bulletin 1559

PRODUCTS AFFECTED

All GTN 650 and GTN 750 navigators marked as Mod Level 4 or previous mod level are affected.

PURPOSE

An issue has been identified where the VOR/LOC/GS may stop functioning in the affected units. This will be indicated by a message on the GTN and the Nav frequencies will be replaced by a red X.

DESCRIPTION

Service Bulletin 1559 provides instruction to inspect and return affected GTN 650/750 units to Garmin for a Mod Level change. Service Bulletin 1559 also provides optional instructions for marking Mod Level 5 on the nameplate (serial tag) of unaffected GTN 650/750 units.

COMPLIANCE

Mandatory for units listed in Table 2. This Service Bulletin must be accomplished by October 31st, 2016.

Optional for units not listed in Table 2.

AFFECTED UNIT IDENTIFICATION

Note: See the following procedure to identify a unit's serial number by powering the unit on rather than removing the unit.

The serial number of the GTN 650/750 can be viewed on-screen using the following instructions:

- 1. Power up the GTN.
- 2. From the Home screen, press the 'System' button.
- 3. From the System screen, press the 'System Status' button. The serial number is displayed at the top of the 'System Status' screen.

Note: Prior to removing the unit for return to Garmin, check the aircraft maintenance records to determine if the GTN has already been updated to Mod Level 5.

Per Table 1, if the unit has **NOT** been previously marked as Mod 5 and the serial number **IS** listed in the Table 2, the unit must be returned to Garmin for modification, refer to Service Bulletin 1559 for further instructions.

Per Table 1, if the unit has **NOT** been previously marked as Mod 5 and the serial number is **NOT** listed in Table 2, it is optional to mark the mod level on the serial tag, refer to Service Bulletin 1559 for further instructions.

Per Table 1, if the unit **IS** marked as Mod 5, it is optional to make an entry in the aircraft maintenance records to indicate that the unit is at Mod Level 5 status in accordance with Garmin Service Bulletin 1559, refer to Service Bulletin 1559 for further instructions.
