The GTS software updates in Table 1 and Table 2 include the following changes:

- Receive and provide ADS-B In traffic to the GTN 6XX/7XX, GDU 620, and TXi Flight Displays.
- Expanded the approved interfaced G950/G1000 software versions to include v13.XX through v15.XX. Also approved the interface of G950/G1000 to the GTS 800.
- Approved the use of Calculated Height Above Ground to determine sensitivity level of traffic target detection and alerting on target proximity (reducing nuisance alerts for traffic in an airport environment).
